President Edna Harris-Kurre introduced the Director of the Patapsco High School Chamber Chorus followed by the Patapsco High School Great Expectations Ensemble. The members were treated to outstanding musical performances from both groups.

President Edna Harris-Kurre led the group in reciting the Pledge of Allegiance. She introduced guests who were in attendance and those expected to arrive later.

President Edna Harris-Kurre introduced the Baltimore County Teacher of the Year and the newly selected Maryland Teacher of the Year, Sean McComb, English teacher from Patapsco High School. After giving the members some family background information, Mr. McComb spoke of school needing to be a safe place for students. He spoke of the influence his high school teachers in Philadelphia who championed him into an education career. Every child needs a champion. He presented the AVID Program, a college preparatory program. President Harris-Kurre introduced Jim Aldon who spoke on impending changes which will affect the newly retirees. Changes will not affect those members already retired. The new retirees will have medical premiums rations for thirty years of more of service change to 85% Board pay and 15% retiree cost gradually changing to 80%/20% by 2020. Our present contract ends in 2019. Dental, Medicare, and Vision plans have

not changed. He spoke of problems resulting from Express Script merger and believes all have been corrected for members. He answered questions about premium cost and the use of the Wellness Office web site regarding flu shots.

Cigna representative announced their 100% preventive care incentives, use of smart phones, on line and telephone information is available 24/7. There are no changes in their plans. Individuals with concerns should check with the representatives at their table.

Kaiser-Permanente representative announced no additional premium cost for retirees with more than twenty years of service and on Medicare.
