The Crab Feast September 20

Camp Running Bear, the Monkton site of the September 20 BCRSPA Crab Feast, features about a half dozen trails including one that leads to the flow of the world-famous Gunpowder River. (The Gunpowder is one of the top seven spots for fly fishing in the world.)


